## **Umpires Corner**

Question - A player misdelivers the jack, the opposition lead moves the mat up the green and delivers a legal jack. The original lead then moves the mat back and says 'I don't want it that far up. Is this allowed?

No - Once the original player has miscast the jack they lose the right to position the mat or the jack. They MUST not reposition the mat. Read Law 6.
